Gifts have been taxed since 1924 and, in 1976, Congress enacted the generation-skipping transfer (GST) tax and linked all three taxes into a unified estate and gift tax.

Under the terms of ATRA, the GST tax exemption increased to \$5.25 million but the GST tax rate jumped to 40%. ATRA also indexed the exemption for inflation,
