Three values of \$25, \$100 and \$250 were issued. In 1982, the coat of arms was changed slightly so the set was reissued with the new version. This time \$500 and \$1000 values were added.

He said the leakages for the first half of this year had already surpassed half of the total RM1.3 billion revenue leakages in 2019. Johari said the Customs Department can claim back leaked revenue that dates back six years under Section 100A(3) of Customs Act 1967 and Section 41B(3) of Excise Act 1976.
